A. Personal Statement

Persistent deficits in health care quality in the United States are well documented and improvement and implementation efforts are now widespread. Unfortunately, little systematic progress has been made in improving optimal population health over the past two decades. I am an Associate Member at the Center for Discovery and Innovation at Hackensack Meridian Health where my research focuses on using implementation science theories and methods to improve care delivery systems by understanding the factors that determine how evidence-based interventions in health and health care are implemented. I bring ethnographic and mixed methods to participatory implementation approaches that inform the development, collection, and analysis of implementation and evaluation data. I have led and participated in improvement and implementation research that focuses specifically on how to use these methodologies to improve outcomes for underserved populations both in the US and globally. I have worked with stakeholders across multiple, varied contexts to understand the facilitators and barriers to successful translation of research into practice and I have taught these skills to different community and partner groups in academic and global settings. In my 8-year involvement with the NIH Office of the Director-funded Environmental exposures on Child Health Outcomes (ECHO) Program, including as faculty for the Participant Engagement; Evaluation; and Return of Results working groups, I have led the development of ECHO's Principles of Stakeholder Engagement and developed strategies to engage research participants in novel ways as well as led several analyses around the experiences of participants and internal and external stakeholders. Currently, I lead as contact PI an NIMH-funded R01 project IMPACT; a three variable hybrid implementation-effectiveness-context cRCT implementing an evidence-based mental health intervention into home visiting programs for women in the perinatal period in Iowa and Indiana. My ethnographic and mixed methods implementation research has focused on community and partner engagement across clinical, public health, and community settings to implement evidence-based interventions in health and healthcare delivery for diverse populations.
